Respected Sir,

I am residing at the above address. I was working as a commanding officer in MNS in the rank of Captain in Indian Army. I was doing my duty lastly in MH Gwalior. In my first tenure of service I was posted in MH Secunderabad commanded by Brigadier Huq who caused sexual harassment to me which I reported to the High Command which is pending. Whereas he had caused so much trouble to me and out of that I was not given duty at the end of the 5 years tenure. Subsequently, I filed the above case in O.A.28/2014 appointing an advocate Arun Deban who was introduced by one advocate Ananth who is known to Durairaj (father-in-law) under mentioned. The said Advocate Arun Deban, with some terrorist back ground, without my knowledge tried to kidnap using uniformed impersonated persons. He also tried to convince me to get divorce with my husband by consent. Since I am not cooperative to him, he withdrew my case in O.A.28/2014 without my instructions and knowledge. Then after learning the sabotage caused by the said Advocate Arun Deban, I went

to the AFT and filed a fresh case in O.A.94/2015. Hence I searched the contacts where which I found that these persons are connected by a Terrorist outfit and all the said persons are interlinked with the under mentioned persons and on a complete enquiry their links would be exposed.

2. One Michael, a srilankan LTTE outfit, is running a Tamil Mission Church, near Anayoor Bus stand, Madurai and is running a prayer hall. He is selecting people for LTTE and sending them to Srilanka. I submit that one kannan of shanti nagar, Madurai introduced me to the said Michael @ Baskar in 2016 to get prayers from the Church which Michael @ Baskar is running. But in this connection after having contacts with the said Michael @ Baskar, he started to persuade me to join the said LTTE organisation and further he asked me to act as an LTTE cadre and asked me to go to Srilanka. He further asked me to bring my husband Reagan to operate the LTTE illegal boats as my husband is educated in Navigation. But I refused and now parting from me, my husband is also involved in this matter with the advice of Jebila, Jebila's father Thrasu Rasu and her family who are working for terrorists. My husband's brother Milton also is involved in this connection. One person namely Suba and Bensing of Thuckalay are connected people.

3. The above said S.Durairaj S/o Sathyam, 615/A3, Melaputhoor Merku, Thomayarpuram, Thadikarankonam, Kanyakumari District is an accused having the possession of the bombs meant for terrorism and had been convicted in that case. Durairaj is having the connection of one Dharmar and Mani and his daughter Jemina, Ravi of paraikode living with Jemina are having the links of terrorists and is residing in the address back of Dhass Hospital, near police station, Palace Road, Thucalay, Kanyakumari District- 629175. All these persons are operating for terrorists and also involved in drugs trafficking. All these persons are supported by Local DMK political party leader Vagila, W/o Mano, 8/4, Santhapuram, Kanyakumari Dist- 629 201.

4. They are torturing me to join the terrorist cadre, though I refuse. These terrorists have set up all the machineries and officials in Madurai not to act against my complaints against them. Since I refuse their wish, they have acted together to separate my husband causing so much cruel activities in my life.

Therefore I request you to take immediate action against the above said persons by enquiring: filing cases against them and to proceed further in the interest Justice.
